Contract, Waiver, Assumption of Risk and Agreement to Hold Harmless - 3



This agreement is made between Canine Sports Corporation hereinafter referred to as CSC and _____ Organization/Business _____ Represented by _____ hereinafter referred to as Organization.

CSC agrees to allow Organization to use the open sided dirt covered arena (and parking area) located at 7705 Gardner Road, Tampa, Florida 33625 for the purpose of _____.

The term of this agreement is for _____ day (s) beginning _____, 20__ and ending _____, 20__. The hours of this agreement are _____ 7am-6pm _____.

Organization agrees to pay CSC the amount specified on the application. Organization also agrees to pay CSC 100 per hour for time over agreement time.

**** If you need the lights on in the arena all day (on cloudy days), there would be an additional charge.

Organization is responsible for portable sanitation - must have at least one handicap toilet, Orange or Green, 1 to 1.5 inch tape for ring(s) three rows, maintaining Dog relief area, Contractor grade trash bags, hammers, parking attendant. (all days) as well as property clean up. The organization is required to get running order approved by CSC president. The organization is responsible for the CSC “ property setup ” to be attached to every final confirmation. The Organization will be charged appropriately starting at \$100, then \$100/hour for any damages/clean up. Organization agrees to reimburse CSC within 24 hours for all additional charges.

Organization hereby agrees that CSC, and K.E.T.C.H. its agents, employees, and representatives will in no way be liable for any injury that may occur to any person, or dog while engaged in, connected with, or in attendance at the above function. Organization agrees to indemnify and hold harmless, CSC, K.E.T.C.H. it’s agents, employees, and representatives against any and all liabilities for personal injury, including injury resulting in deaths or damage to property or both, resulting directly or indirectly from the use by Organization of CSC’s property or equipment, and agrees to reimburse CSC in defending any such claims that may result there from. Equipment rental is at your own risk. Treat the equipment as if it were your own. If the equipment is damaged from abuse, Organization agrees to reimburse CSC for new replacement within 24 hours. Purchase price must be provided from a CSC approved company. Organization agrees to inspect equipment 24 hours before event, Equipment inspection (1) safety issues, and (2) Equipment is to AKC/USDAA regulations. Equipment is to be placed neatly back when event is over, a map will be provided.

The organization must carry a \$1,000,000 liability insurance policy with the Canine Sports Complex & KETCH listed as additional insured. Copy of policy must be presented one week prior to event. Organization agrees that CSC, KETCH its agents, employees, and representatives are not responsible for any injuries caused by equipment malfunction, including but not limited to equipment previously inspected by Organization. CSC is not responsible for any damage to equipment brought in by Organization or any other person. A \$500 non-refundable deposit is required at the time you reserve the facility. Rental paid a week before the event. If Organization cancels event, \$500 deposit is forfeited.

Organization agrees that sale of any item or service must be pre-approved by CSC. CSC/KETCH reserves the right to sell merchandise and services at any event.

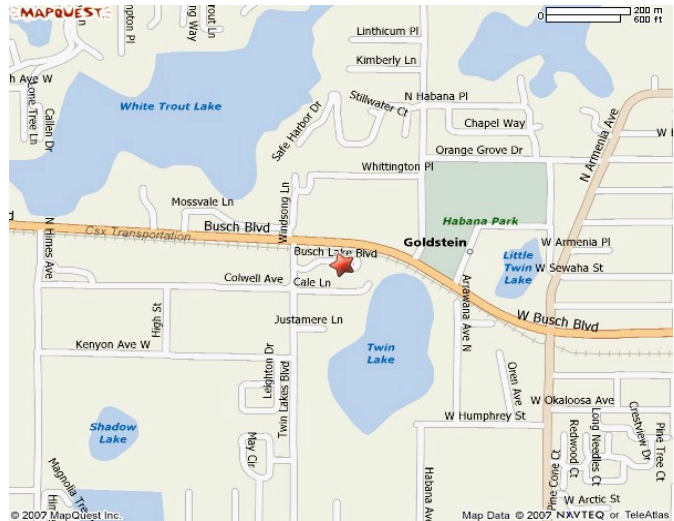

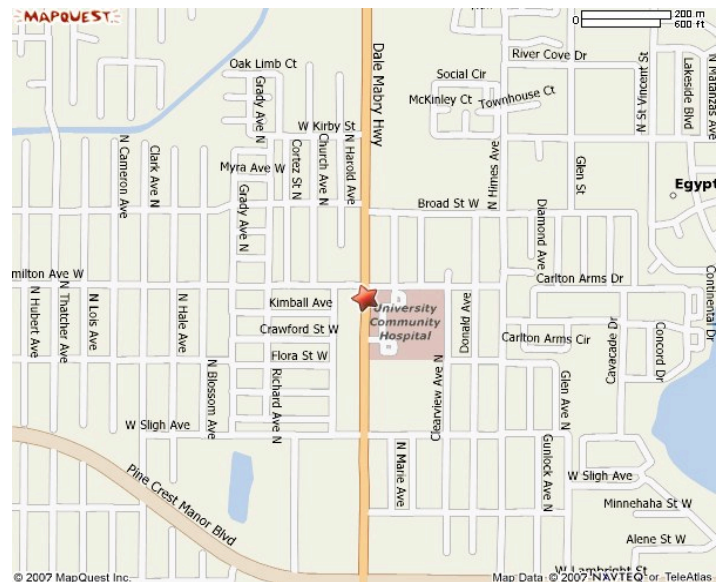
