Waiver Assumption of Rick and Agreement to Hold Harmless

I hereby waive and release Canine Sports Corporation ("CSC") & K.E.T.C.H., its employees, officers, directors and representatives of all responsibility for any property damage caused by or to my vehicle, and/or RV and any damage, to my vehicle including ALL of its contents, including dogs, lost or stolen items, acts of god, weather & wind and electrical damages. I will reimburse all expenses incurred in any damage, and I am properly insured to cover any expenses.

In consideration of and as inducement to the acceptance of my participation in this event, I hereby agree to indemnify and hold harmless CSC and KETCH, its employees, officers, directors and representatives from any and all claims, or claims by any member of my family or any other person accompanying me to any event or function of CSC or KETCH while on the grounds or the surrounding property thereto as a result of any action by any dog including my own or any other persons animal.

I understand that attendance at a dog function in not without risk to my self, members of my family or guests who may attend, or to my dog, because some of the dogs to which I (we) will be exposed may be difficult to control and may be the cause of injury even when handled with the greatest of care.

I further agree to immediately reimburse KETCH for any physical harm inflicted upon livestock, whether it is sheep, chickens or dogs, by myself, my family members, and/or my dogs. Should harmed stock or dogs require veterinary treatment, I agree to immediately reimburse KETCH or dog's owner for veterinary services rendered upon presentation of a bill. I understand the decision to seek veterinary treatment will be made solely by KETCH/owner. **Any dog that becomes aggressive or disruptive towards other dogs or people will be asked to leave the property.**
